POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 18 MAY 2018

At the annual general meeting of Techcomp (Holdings) Limited (the “**Company**”) held on Friday, 18 May 2018 (the “**AGM**”), votes of all proposed resolutions referred to in the notice of the AGM dated 17 April 2018 (the “**AGM Notice**”) were taken by poll.

As at the date of the AGM, the number of issued shares of the Company was 275,437,000, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There were no shares entitling the holders to attend and abstain from voting in favour of the resolutions proposed at the AGM, or abstain from voting as required under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No shareholder had indicated in the circular of the Company dated 17 April 2018 containing the AGM Notice that he/she intended to vote against or abstain from voting on the resolutions proposed at the AGM.

T S Tay Public Accounting Corporation, the external accountant of the Company, acted as the scrutineer of the vote-taking at the AGM.
